### Fund update for the quarter ended 30 September 2018

This fund update was first made publicly available on 19 October 2018.

### What is the purpose of this update?

This document tells you how Ethica has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

Invests in a mix of income and growth assets. Designed for investors that want a balanced investment option. A socially responsible fund which excludes assets that do not meet the fund's defined ethical investment standards. Negative annual returns may occur once in every 5-7 years on average.

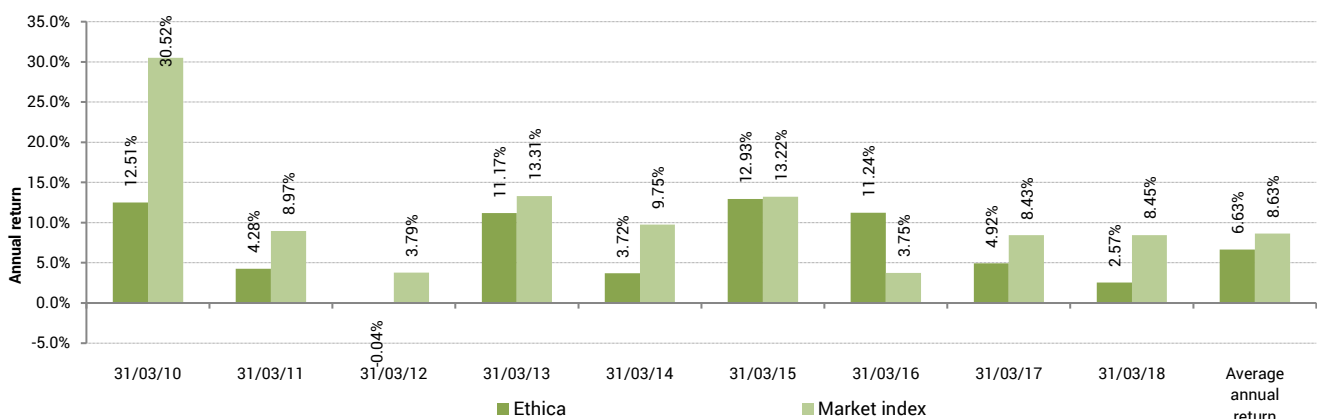
### What are the risks of investing?

#### Risk indicator for Ethica



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

### How has the fund performed?

Investors in Ethica are charged fund charges. In the year to 31 March 2018 these were:

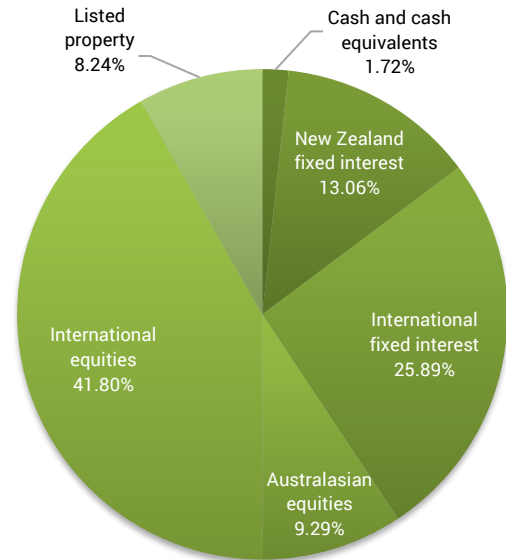
### Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$663 (that is 6.63% of her initial \$10,000). Jess paid other charges of \$30. This gives Jess a total return after tax of \$633 for the year.

The fund's foreign currency exposure may be hedged to the New Zealand dollar, and hedging levels will vary between 0% and 110%. As at 30 September 2018, 0% of the fund's foreign currency exposure was hedged.
