What is the purpose of this update?

This document tells you how the Overseas Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Overseas Shares Fund is designed to provide a return (after tax, fees and other expenses) that reflects the aftertax return on the international share markets of developed economies.

Other specific risks



In particular, while the SuperLife KiwiSaver scheme's philosophy is that a passive approach to investing will deliver better long-term results, we make some active management decisions. There is a risk that this may result in the fund achieving a return that is lower than its investment objective.

GST is included in the fund charges set out above.


Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$317 (that is 3.17% of her initial \$10,000). Jess paid other charges of \$30. This gives Jess a total return after tax of \$287 for the year.
