### Fund update for the quarter ended 30 September 2020

This fund update was first made publicly available on 29 October 2020.

### What is the purpose of this update?

This document tells you how the Global Property Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

Invests in international property and designed to reflect the return (before tax, fees and other expenses) on New Zealand and international property markets.

### What are the risks of investing?

#### Risk indicator for the Global Property Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

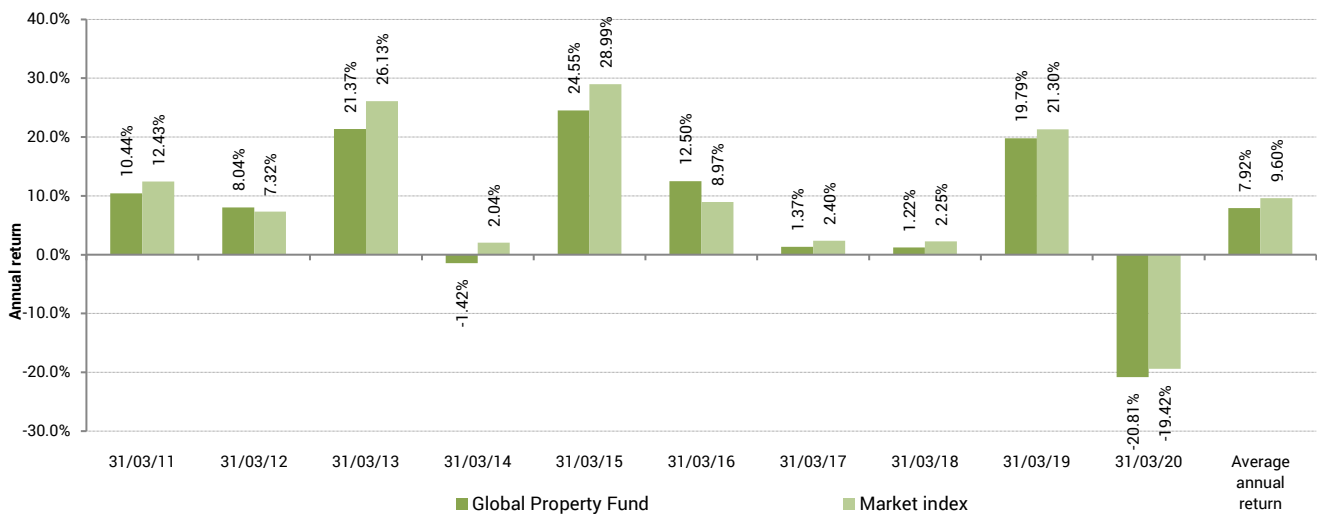
### How has the fund performed?

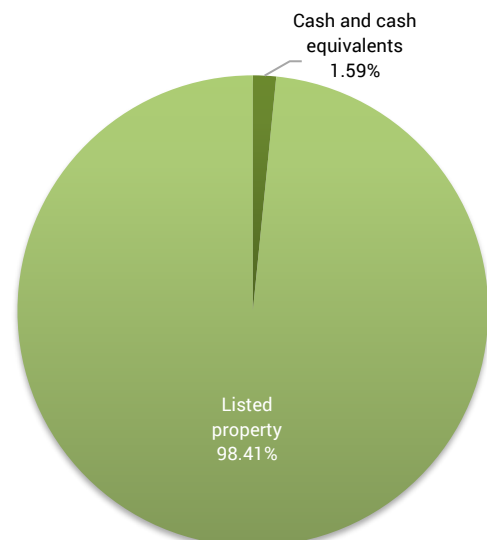
## Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of -\$1,676 (that is -16.76% of her initial \$10,000). Jess paid other charges of \$30. This gives Jess a total loss after tax of -\$1,706 for the year.

## Currency hedging

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 100% (although the actual hedging level may differ from this because of cash flow and market movements).
