In previous fund updates, the market index annual return data was calculated incorrectly.

Fund update for the quarter ended 30 June 2021

This fund update was first made publicly available on 24 April 2023.

What is the purpose of this update?

This document tells you how the Overseas Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

What are the risks of investing?

Risk indicator for the Overseas Shares Fund




Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$2,756 (that is 27.56% of her initial \$10,000). Jess paid other charges of \$30. This gives Jess a total return after tax of \$2,726 for the year.

- 2 The administration fee in the year to 31 March 2021 is stated net of an income tax deduction that was applied in calculating your PIE tax payable (the deduction was paid to us). On 1 April 2021, we stopped doing this this means the total fee you will now pay us will be lower.
