## SuperLife High Growth Fund

This is a replacement fund update dated 21 December 2023, which replaces the previous fund update dated 31 July 2023. ### Fund update for the quarter ended 30 June 2023

### What is the purpose of this update?

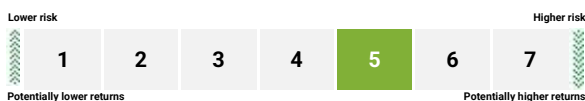
### Description of this fund

Invests in growth assets and is designed for investors that want an aggressive investment option that invests in shares and property. Negative annual returns may occur once in every 2-4 years on average.

### What are the risks of investing?

#### Risk indicator for the SuperLife High Growth Fund

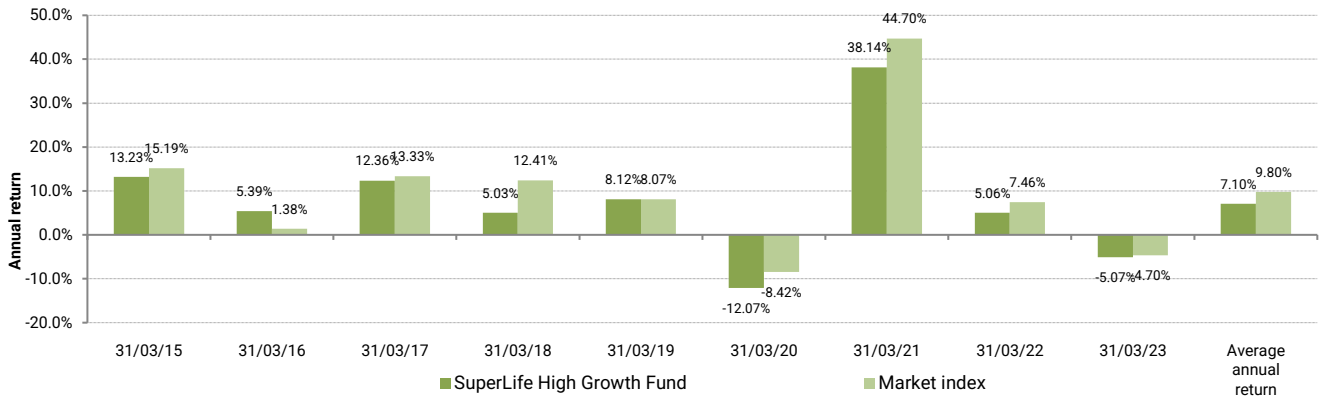
### How has the fund performed?

## Annual return graph



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 30 June 2023.

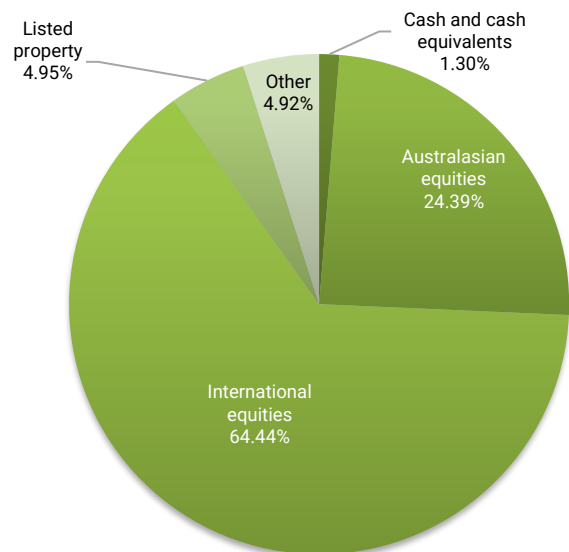
## Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$1060 (that is 10.60% of Jess's initial \$10,000). Jess paid other charges of \$30. This gives Jess a total return after tax of \$954 for the year.

### Currency hedging

As at 30 June 2023 the fund's exposure to assets denominated in foreign currencies was 71.43%, of which 65.30% was hedged. This means the fund's unhedged foreign currency exposure was 24.79% of the net asset value of the fund. ## Notes

- 1 These charges refer to the normal fund operating costs that are charged to the fund. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. Some of these are fixed costs so the amount shown can range from 0% up to the total fund charges depending on the total value of the fund.
- 2 The 'other' category refers to an investment in infrastructure. The underlying investments are infrastructure securities listed in developed countries.
