SuperLife Age Steps - Age 30

This is a replacement fund update dated 29 May 2024, which replaces the previous fund update dated 3 May 2023. The market index return data in the "How has the fund performed?" section, including the annual return graph, has been updated to show correct market index returns over the relevant periods.

Investment update for the quarter ended 31 March 2023

This investment update was first made publicly available on 29 May 2024.

What is the purpose of this update?

This document tells you how SuperLife Age Steps - Age 30 (the stage) has performed and what fees were charged. The document will help you to compare the stage with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this stage

SuperLife Age Steps automatically sets the proportion of your investment in income and growth assets based on your age. As you get older, the proportion of your investment in more volatile growth assets will be reduced, lowering the expected size of the ups and downs in the value of your investment. This option may be suitable if you are saving for retirement (assumed to be age 65), and assumes you will continue to invest your savings and spend them over your retirement period.

Your SuperLife Age Steps - Age 30 investment will be allocated 20.8% to income assets and 79.2% to growth assets.

Total value of the stage: \$5,901,816

Number of investors in the stage: 1,461

What are the risks of investing?

Risk indicator for SuperLife Age Steps - Age 30



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the stage's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



Annual return graph


Example of how this applies to an investor

Jess had \$10,000 in the stage at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted but before tax of \$-438 (that is -4.38% of Jess's initial \$10,000). Jess also paid \$30 in other charges. This gives Jess a total loss after tax of \$-475 for the year.

Notes
