


Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted but before tax of \$-196 (that is -1.96% of Jess's initial \$10,000). Jess paid other charges of \$30. This gives Jess a total loss after tax of \$-258 for the year.

Currency hedging

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 100.00% of the fund's foreign currency exposure. The actual hedging level can be anywhere in the 0% - 120% range. As at 31 Mar 23, 100.00% of the fund's foreign currency exposure was hedged.
