Fund update for the quarter ended 30 September 2023 This fund update was first made publicly available on 30 October 2023.

What is the purpose of this update?

This document tells you how the SuperLife Default Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Number of investors in the fund:

The SuperLife Default Fund invests in a mix of income and growth assets. Designed for investors that want a balanced investment option. Excludes investments in illegal weapons (cluster munitions, anti-personnel mines and nuclear explosive devices) and fossil fuel production. Negative annual returns may occur once in every 5-7years on average. The fund is a Default KiwiSaver Fund

Total value of the fund: \$471,305,440 51,283

The date the fund started: 1 December 2021

What are the risks of investing?

Risk indicator for the SuperLife Default Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a riskfree investment, and there are other risks that are not captured by this rating.



How has the fund performed?

Annual return graph


Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$778 (that is 7.78% of their initial \$10,000). Jess paid other charges of \$30. This gives Jess a total return after tax of \$658 for the year.

Currency hedging

As at 29 September 23 the fund's exposure to assets denominated in foreign currencies was 36.97%, of which 52.18% was hedged. This means the fund's unhedged foreign currency exposure was 17.68% of the net asset value of the fund. Notes

- Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 3 years and 2 months of market index returns.
- These charges refer to the normal fund operating costs that are charged to the fund. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. Some of these are fixed costs so the amount shown can range from 0% up to the total fund charges depending on the total value of the fund.
- The SuperLife KiwiSaver scheme has an administration fee of \$30 a year. You do not pay the administration fee if you have all your money invested in the SuperLife Default Fund.
