### Fund update for the quarter ended 31 December 2025

This fund update was first made publicly available on 12 February 2026.

### What is the purpose of this update?

This document tells you how the Overseas Bonds Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

Invests in international bonds and is designed to reflect the return (before tax, fees and other expenses) on international bond markets of developed economies.

### What are the risks of investing?

#### Risk indicator for the Overseas Bonds Fund




## Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$400 (that is 4.00% of Jess's initial \$10,000). Jess also paid \$30 in other charges. This gives Jess a total return after tax of \$372 for the year.
