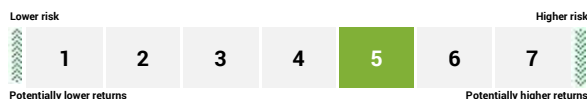
Description of this fund

Invests in international shares and is designed to track the return (before tax, fees and other expenses) of the MSCI World ex Australia ESG Screened Index.

What are the risks of investing?

Risk indicator for the Overseas Shares Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

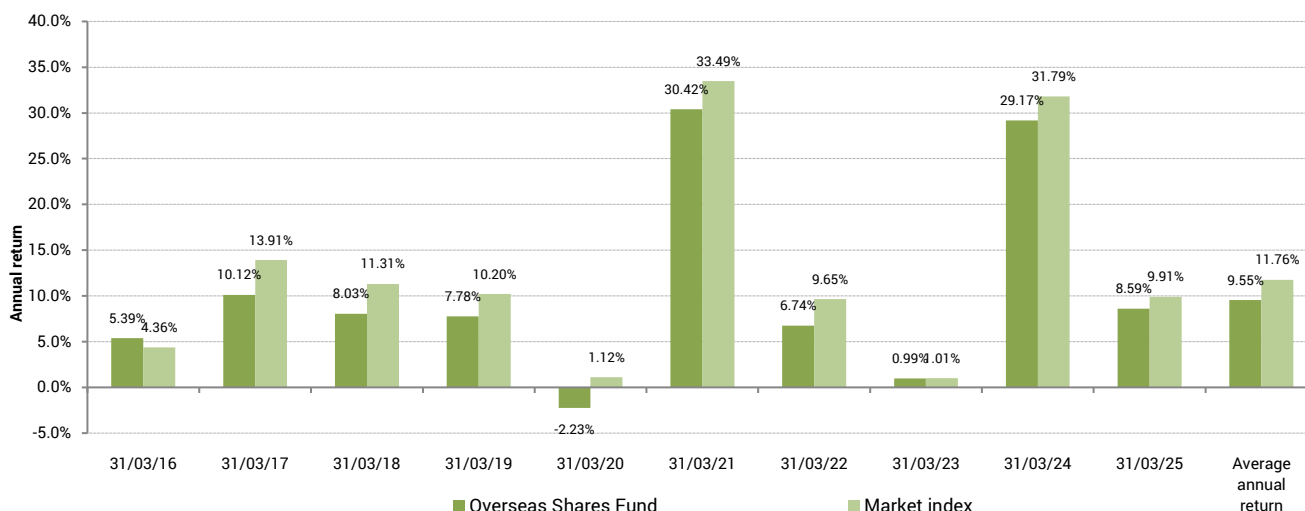
How has the fund performed?

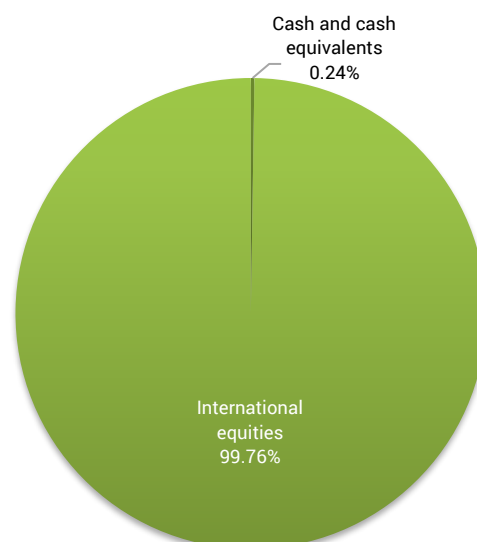
Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$1,507 (that is 15.07% of Jess's initial \$10,000). Jess also paid \$30 in other charges. This gives Jess a total return after tax of \$1,334 for the year.
