# **SuperLife Conservative Fund**

#### Fund update for the guarter ended 30 September 2025

This fund update was first made publicly available on 29 October 2025.

#### What is the purpose of this update?

This document tells you how the SuperLife Conservative Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## **Description of this fund**

Invests mostly in income assets and is designed for investors that want a conservative investment option. Negative annual returns may occur once in every 7-10 years on average.



# **Example of how this applies to an investor**

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$773 (that is 7.73% of Jess's initial \$10,000). Jess also paid \$30 in other charges. This gives Jess a total return after tax of \$618 for the year.

#### **Currency hedging**

As at 30 September 2025 the fund's exposure to assets denominated in foreign currencies was 54.03%, of which 74.93% was hedged. This means the fund's unhedged foreign currency exposure was 13.55% of the net asset value of the fund. #### **Notes**

- These charges refer to the normal fund operating costs that are charged to the fund.
