What is the purpose of this update?

This document tells you how the Total World (NZD Hedged) Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Total World (NZD Hedged) Fund invests in international shares and is designed to track the return (before tax, fees and other expenses) of the FTSE Global All Cap Index, 100% hedged to the New Zealand dollar.

What are the risks of investing?

Risk indicator for the Total World (NZD Hedged) Fund



Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$1,583 (that is 15.83% of Jess's initial \$10,000). Jess also paid \$30 in other charges. This gives Jess a total return after tax of \$1,584 for the year.

Currency hedging

As at 30 September 2025 the fund's exposure to assets denominated in foreign currencies was 101.77%, of which 97.23% was hedged. This means the fund's unhedged foreign currency exposure was 2.82% of the net asset value of the fund.
