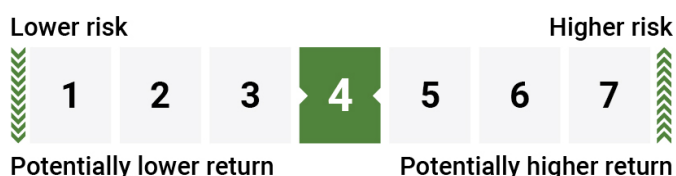
Description of this fund

Invests in international bonds and is designed to provide returns (before tax, fees and other expenses) consistent with the Bloomberg Global Aggregate Ex Treasury Total Return Index (100% NZD Hedged).

What are the risks of investing?

Risk indicator for the Overseas Non-government Bonds Fund

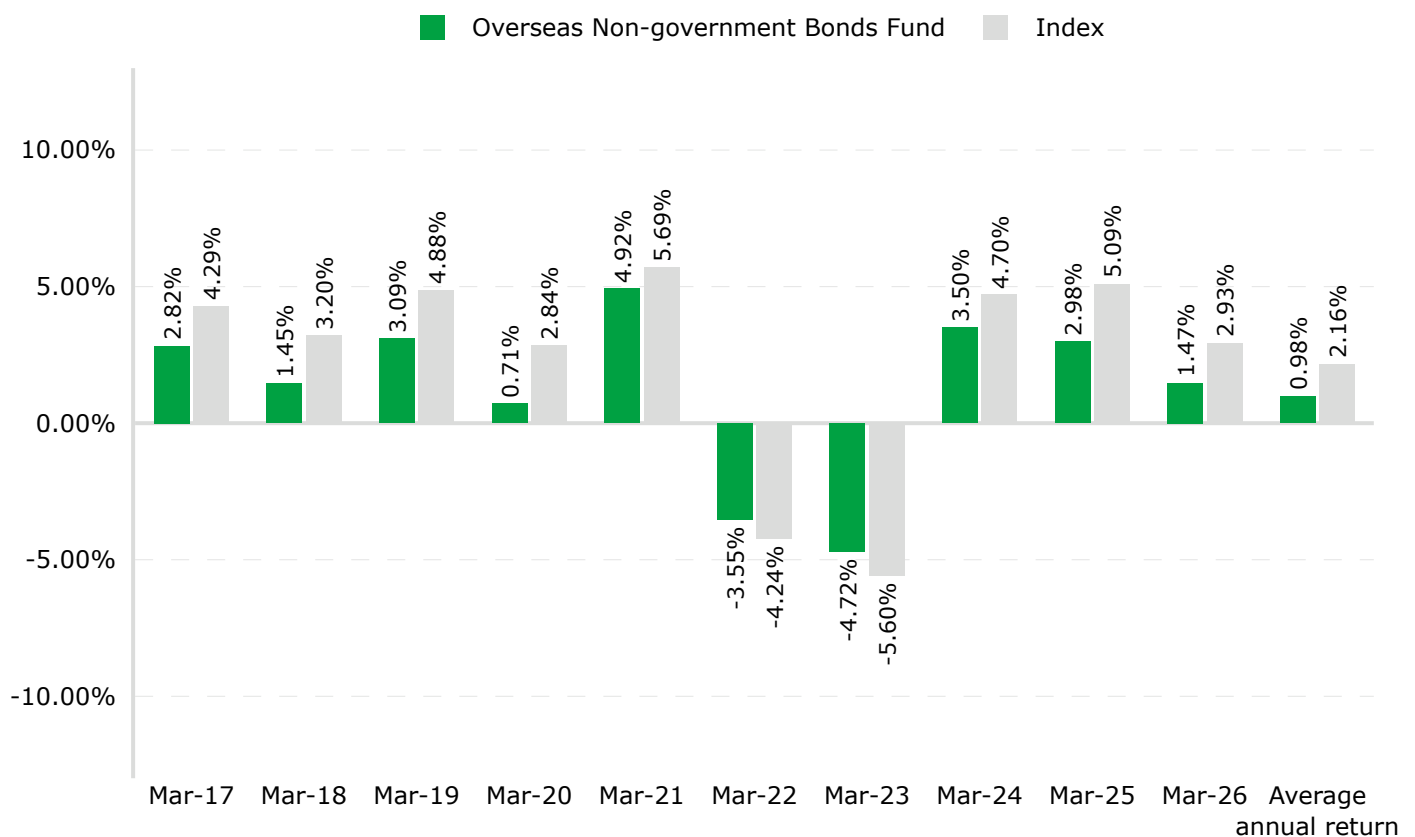

How has the fund performed?

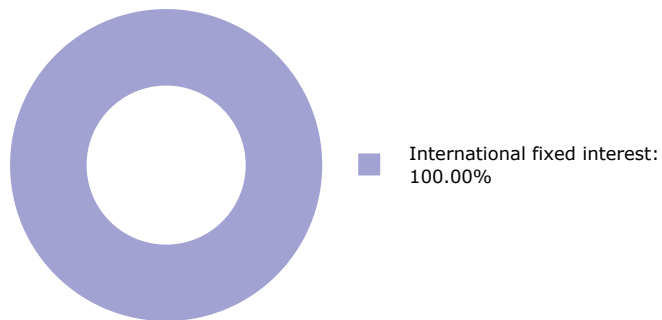
Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$224 (that is 2.24% of Jess's initial \$10,000). Jess also paid \$30.00 in other charges. This gives Jess a total return after tax of \$128 for the year.

Currency hedging

As at 30 June 2026 the fund's exposure to assets denominated in foreign currencies was 95.26%, of which 100.00% was hedged. This means the fund's unhedged foreign currency exposure was 0.00% of the net asset value of the fund.
