Fund update for the quarter ended 31 December 2018

This fund update was first made publicly available on 28 February 2019.

This is a replacement fund update. This replaces the fund update first made publicly available on 13 February 2019. Note 1 (which relates to total management and administration charges) has been added to this fund update.

What is the purpose of this update?

This document tells you how the Emerging Markets Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Emerging Markets Fund is designed to provide a return (after tax, fees and other expenses) that reflects the after-tax return on international share markets of emerging economies.

We will not be liable for any loss you may suffer if this happens.

There is also investment management risk. In particular, while the SuperLife UK pension transfer scheme's philosophy is that a passive approach to investing will deliver better long-term results, we make some active management decisions. There is a risk that this may result in the fund achieving a return that is lower than its investment objective.



Small differences in fees and charges can have a big impact on your investment over the long term.


Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$1,106 (that is -11.06% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total loss after tax of -\$1,166 for the year.
