This fund update was first made publicly available on 25 July 2018.

What is the purpose of this update?

This document tells you how the Overseas Shares (Currency Hedged) Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Overseas Shares (Currency Hedged) Fund is designed to provide a return (after tax, fees and other expenses) that reflects the after-tax return on the international share markets of developed economies, excluding the impact of foreign currency movements.

What are the risks of investing?

Risk indicator for the Overseas Shares (Currency Hedged) Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

How has the fund performed?

The market index annual return is based on the annual return of the FTSE Developed All-Cap Index (100% hedged to the New Zealand dollar). The market index was changed on 29 June 2018 to ensure the index that the fund is measured against is better aligned to the assets the fund holds.



These risks include the risk that changes to the UK's rules for recognised overseas pension schemes (**ROPS**) limit your ability to withdraw your investments or affect the UK tax you pay on your investment. We will not be liable for any loss you may suffer if this happens.

There is also investment management risk. In particular, while the SuperLife UK pension transfer scheme's philosophy is that a passive approach to investing will deliver better long-term results, we make some active management decisions. There is a risk that this may result in the fund achieving a return that is lower than its investment objective.

Small differences in fees and charges can have a big impact on your investment over the long term.


Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$789 (that is 7.89% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$729 for the year.

Currency hedging

The fund's foreign currency exposure is hedged to the New Zealand dollar, and hedging levels will vary between 90% and 110%. As at 30 June 2018, 102.24% of the fund's foreign currency exposure was hedged.
