What is the purpose of this update?

Invests in a mix of income and growth assets. Designed for investors that want a balanced investment option. Negative annual returns may occur once in every 5-7 years on average.


What are the risks of investing?

Risk indicator for SuperLife⁶⁰



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

How has the fund performed?

The market index was changed on 29 June 2018 to ensure the index that the fund is measured against is better aligned to the assets the fund holds.

What fees are investors charged?

Investors in SuperLife⁶⁰ are charged fund charges. In the year to 31 March 2018 these were:

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$609 (that is 6.09% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$549 for the year.
