What is the purpose of this update?

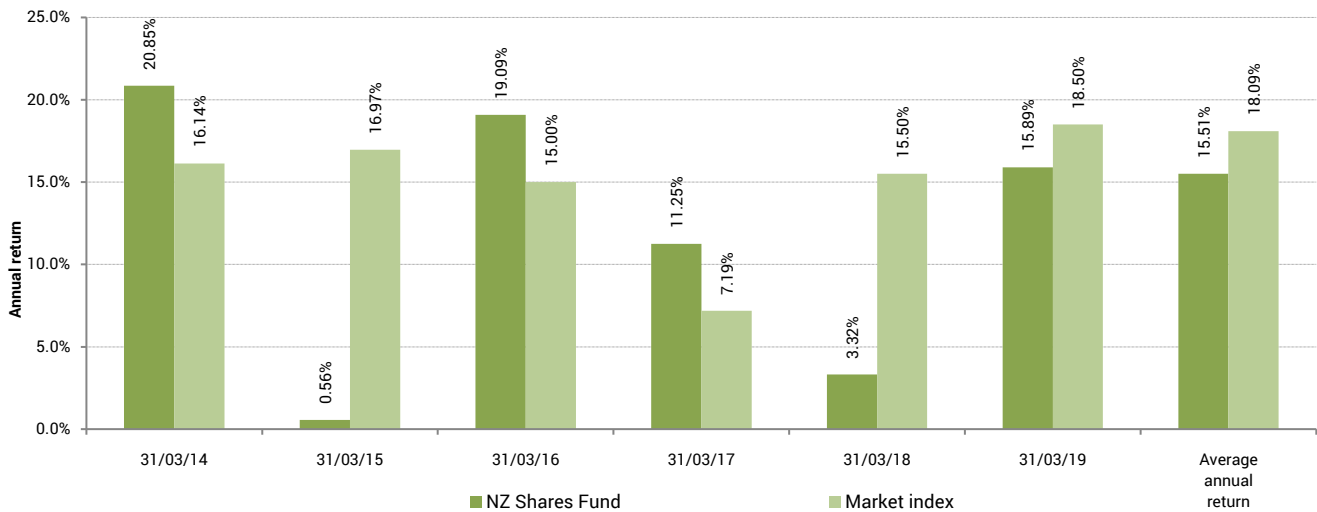
Other specific risks

What fees are investors charged?

Investors in the NZ Shares Fund are charged fund charges. In the year to 31 March 2019 these were:

GST is included in the fund charges set out above.

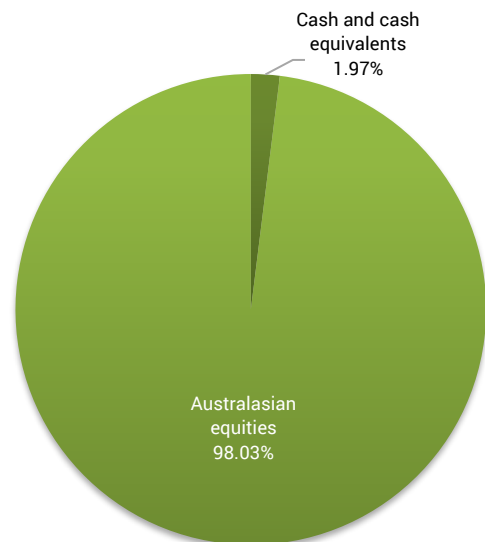
Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$2,264 (that is 22.64% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$2,204 for the year.
