### Fund update for the quarter ended 31 December 2019

This fund update was first made publicly available on 13 February 2020.

### What is the purpose of this update?

This document tells you how the Europe Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

The Europe Fund invests in the Smartshares Exchange Traded Funds' Smartshares Europe ETF.

### What are the risks of investing?

#### Risk indicator for the Europe Fund<sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

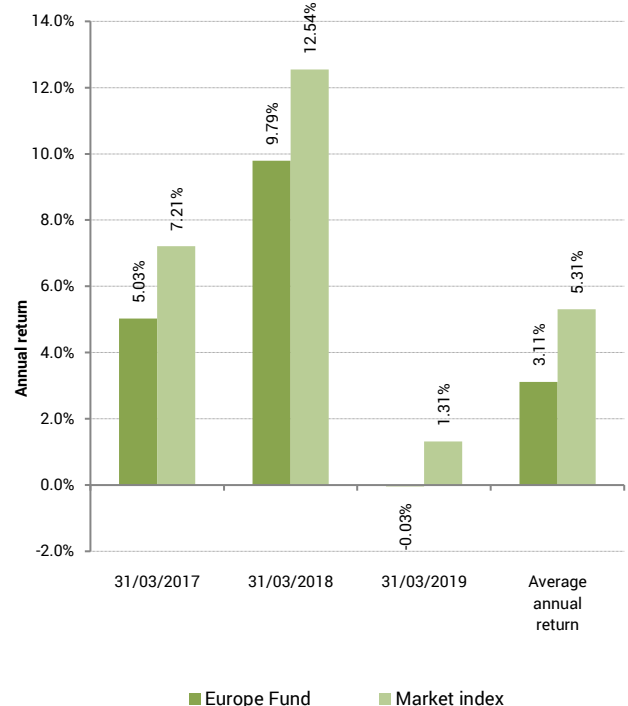

### How has the fund performed?

### What fees are investors charged?

Investors in the Europe Fund are charged fund charges. In the year to 31 March 2019 these were:

GST is included in the fund charges set out above.

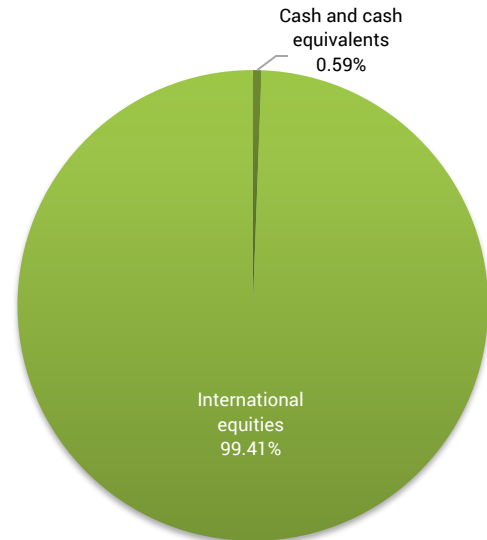
### Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$2,151 (that is 21.51% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$2,091 for the year.

## Notes

- 2 The top 10 investments listed in the table exclude current assets and current liabilities, and as a result do not sum to 100%.
- 3 The Smartshares Europe ETF is also managed by Smartshares. As a result, the table lists the individual assets of the Smartshares Europe ETF as if they were individual assets directly held by the fund.
