What is the purpose of this update?

The Overseas Shares Fund is designed to provide a return (after tax, fees and other expenses) that reflects the after-tax return on the international share markets of developed economies.

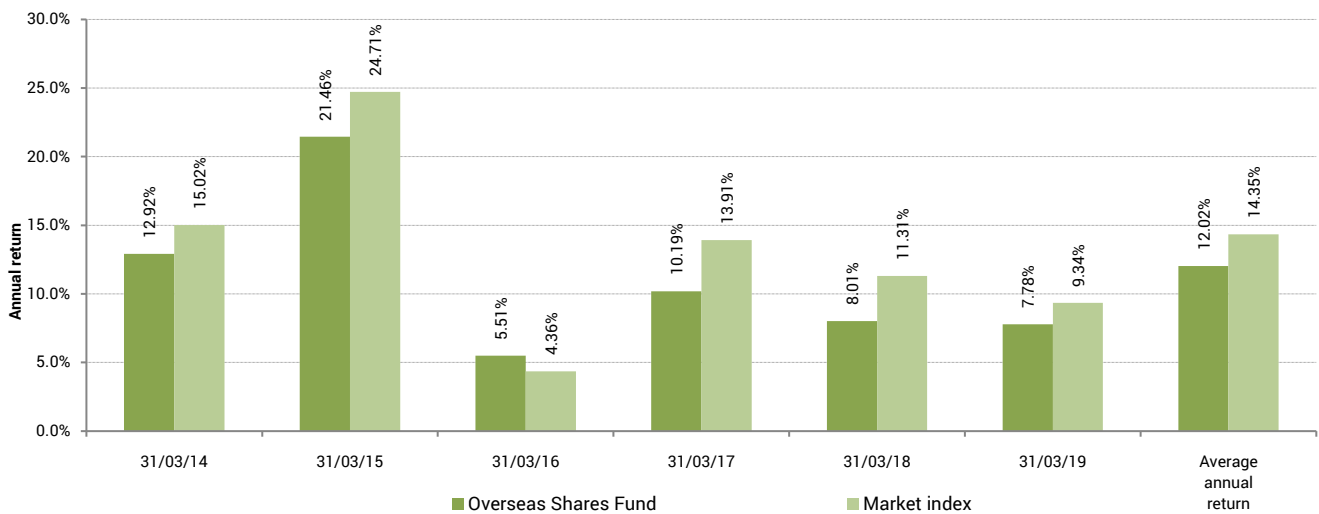

GST is included in the fund charges set out above.

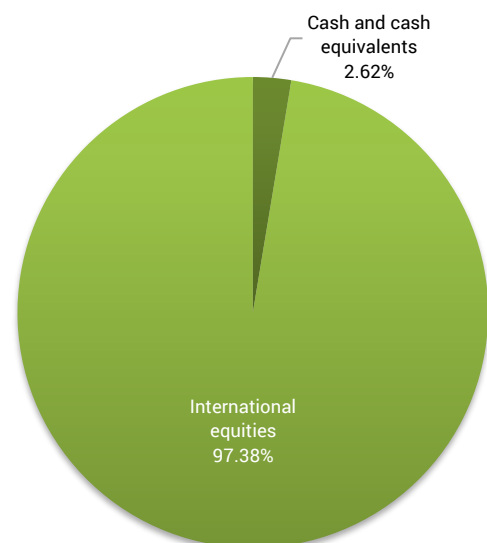
Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$2,367 (that is 23.67% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$2,307 for the year.
