What is the purpose of this update?


What are the risks of investing?

Risk indicator for SuperLife Income



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

How has the fund performed?

Investors in SuperLife Income are charged fund charges. In the year to 31 March 2019 these were:

Small differences in fees and charges can have a big impact on your investment over the long term.


Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$343 (that is 3.43% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$283 for the year.

The fund's foreign currency exposure may be hedged to the New Zealand dollar, and hedging levels will vary between 0% and 110%. As at 31 March 2019, 96.55% of the fund's foreign currency exposure was hedged.
