What is the purpose of this update?

This document tells you how the S&P/NZX 50 Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The S&P/NZX 50 Fund invests in New Zealand shares and designed to track the return (before tax, fees and other expenses) on the S&P/NZX 50 Index.

What are the risks of investing?

Risk indicator for the S&P/NZX 50 Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Example of how this applies to an investor

Jess had \$10,000 in the fund on 15 July 2020 and did not make any further contributions. On 31 December 2020, Jess received a return after fund charges were deducted of \$1324 (that is 13.24% of her initial \$10,000). Jess paid other charges of \$25 This gives Jess a total gain after tax of \$1299 for the 5 months and 15 days.

Material changes

Notes

- We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges.
