### What is the purpose of this update?

This document tells you how the Overseas Bonds Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

The Overseas Bonds Fund is designed to provide a return (after tax, fees and other expenses) that reflects the after-tax return on international bond markets of developed economies.

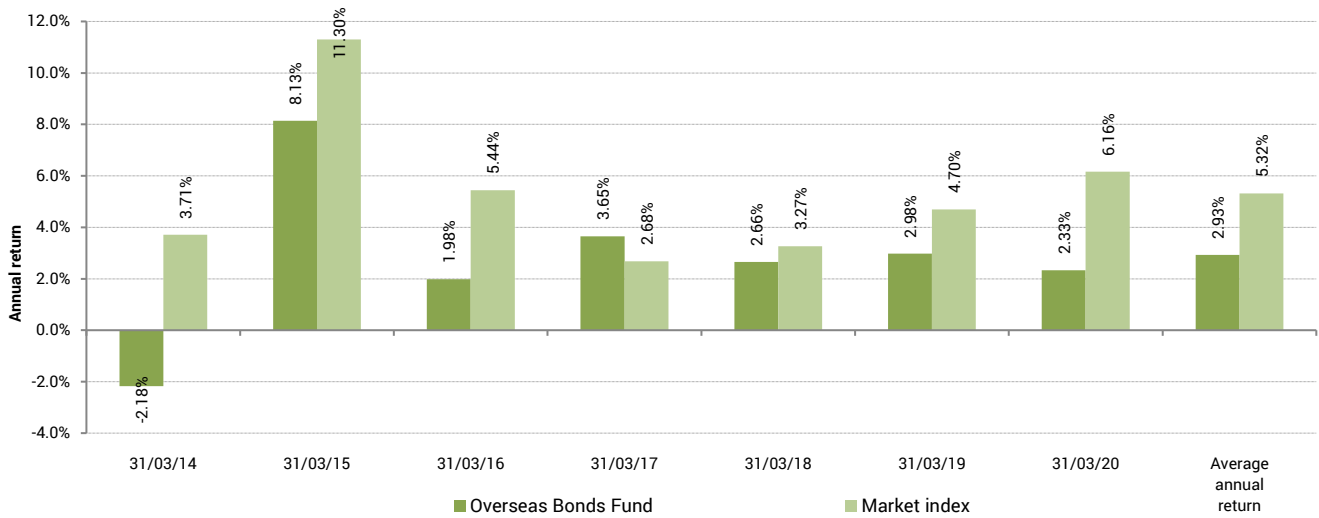

## What fees are investors charged?

Investors in the Overseas Bonds Fund are charged fund charges. In the year to 31 March 2020 these were:

GST is included in the fund charges set out above.

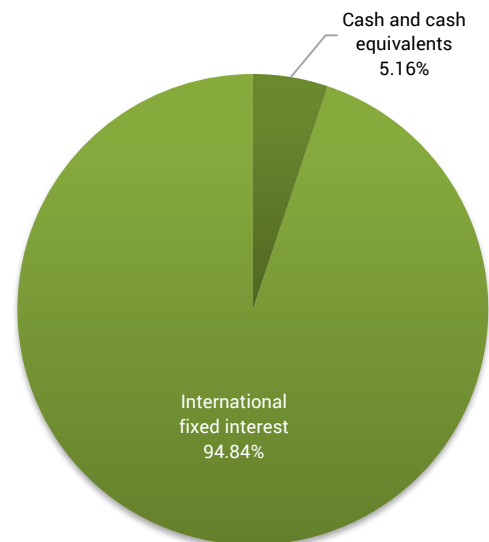
## Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$233 (that is 2.33% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$173 for the year.
