This fund update was first made publicly available on 1 May 2020.

What is the purpose of this update?

This document tells you how the US Large Value Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The US Large Value Fund invests in the Smartshares Exchange Traded Funds' Smartshares US Large Value ETF.

Total value of the fund: \$98,574

Number of investors in the fund: 6

The date the fund started: 21 September 2015

What are the risks of investing?

Risk indicator for the US Large Value Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



How has the fund performed?

GST is included in the fund charges set out above.


Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$258 (that is -2.58% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total loss after tax of -\$318 for the year.

Material changes

Notes

As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 6 months of market index returns.
- 2 The top 10 investments listed in the table exclude current assets and current liabilities, and as a result do not sum to 100%.
