What is the purpose of this update?




Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of -\$1,690 (that is -16.90% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total loss after tax of -\$1,750 for the year.

Currency hedging

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 100% (although the actual hedging level may differ from this because of cash flow and market movements). As at 30 September 2020, 101.48% of the fund's foreign currency exposure was hedged.
