What is the purpose of this update?




Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$7 (that is 0.07% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total loss after tax of -\$53 for the year.
