# What is the purpose of this update?

# What are the risks of investing?

#### **Risk indicator for the Overseas Shares Fund**




#### Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$2,434 (that is 24.34% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$2,374 for the year.

#### **Notes**

- 1 On 1 April 2021, the fund's total fund charges was increased to 0.69% p.a. of the fund's net asset value. The total fund charges for the next fund year (being the year ending 31 March 2023) are expected to be at least that level.
- 2 We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges.
- 3 The top 10 investments listed in the table exclude current assets and current liabilities, and as a result do not sum to 100%.
