# What is the purpose of this update?

# What are the risks of investing?

#### **Risk indicator for the Australian Dividend Fund**



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


# How has the fund performed?


#### Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$1,975 (that is 19.75% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$1,915 for the year.
