What is the purpose of this update?

This document tells you how the Overseas Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. What are the risks of investing?

Risk indicator for the Overseas Shares Fund




Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$2,753 (that is 27.53% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$2,693 for the year.
