What is the purpose of this update?

This document tells you how the SuperLife Conservative Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

Invests mostly in income assets and designed for investors that want a conservative investment option. Negative annual returns may occur once in every 7-10 years on average.

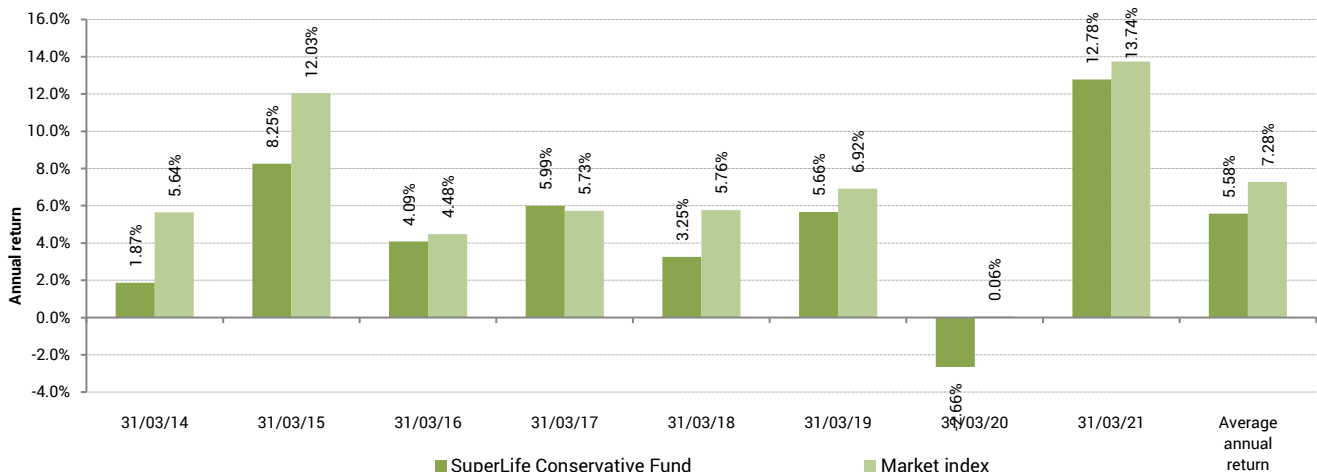
What are the risks of investing?

Risk indicator for the SuperLife Conservative Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

How has the fund performed?

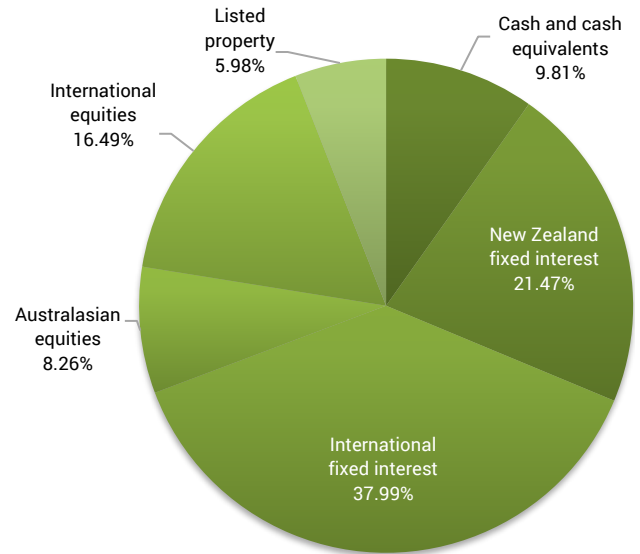
Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$844 (that is 8.44% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$784 for the year.

Currency hedging

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 90%. The actual hedging level can be anywhere in the 0% - 120% range. As at 30 June 2021, 87.96% of the fund's foreign currency exposure was hedged.
