What is the purpose of this update?

This document tells you how the Overseas Shares (Currency Hedged) Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

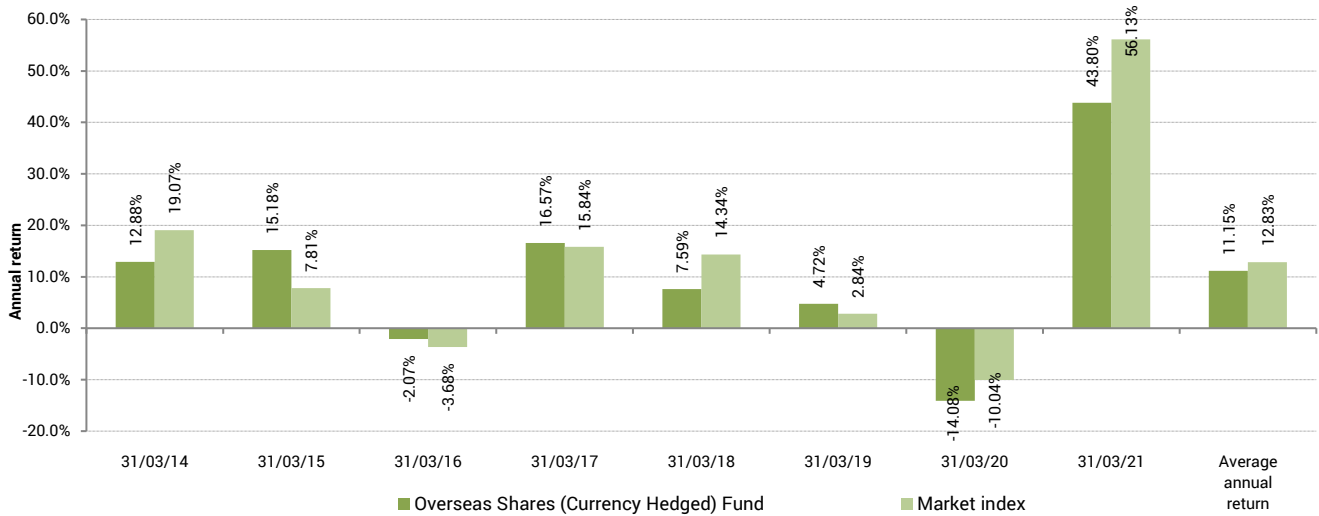

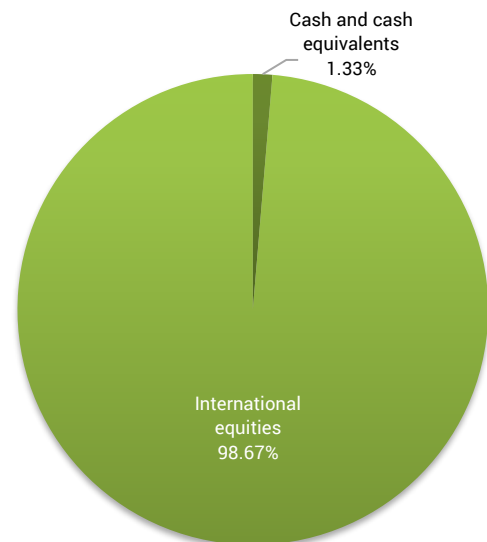
Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$4,380 (that is 43.80% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$4,320 for the year.

Currency hedging

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 100% (although the actual hedging level may differ from this because of cash flow and market movements). As at 31 March 2021, 100.35% of the fund's foreign currency exposure was hedged.

- 1 On 1 April 2021, the fund's total fund charges increased to 0.69%.
- 2 We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges.
- 3 The top 10 investments listed in the table exclude current assets and current liabilities, and as a result do not sum to 100%.
