What is the purpose of this update?

This document tells you how the Global Property Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Invests in international property and is designed to reflect the return (before tax, fees and other expenses) on New Zealand and international property markets.

What are the risks of investing?

Risk indicator for the Global Property Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


How has the fund performed?

Annual return graph



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 December 2022.


Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$2,302 (that is -23.02% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total loss after tax of -\$2,362 for the year.

The top 10 investments make up 75.15% of the fund's net asset value.

Currency hedging

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 100% of the fund's foreign currency exposure. The actual hedging level can be anywhere in the 0% - 120% range. As at 30 December 2022, 98.86% of the fund's foreign currency exposure was hedged.
