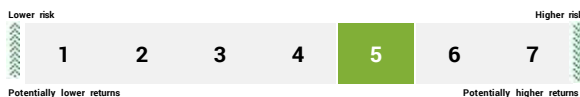
Description of this fund

What are the risks of investing?

Risk indicator for the Overseas Shares Fund

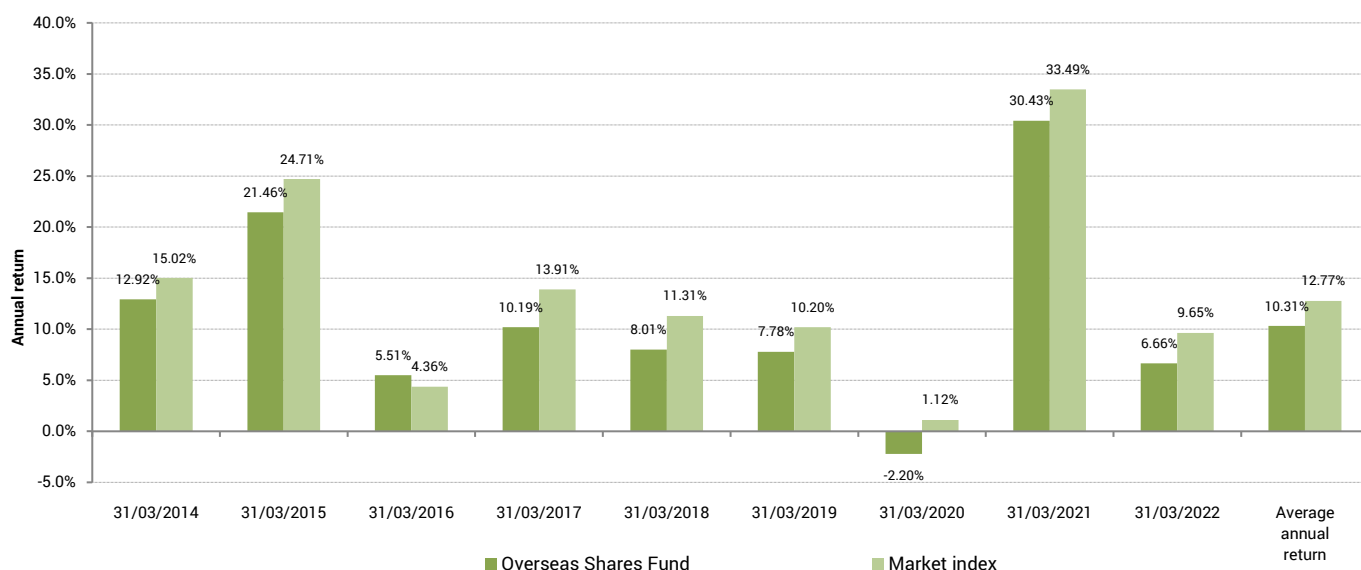
How has the fund performed?

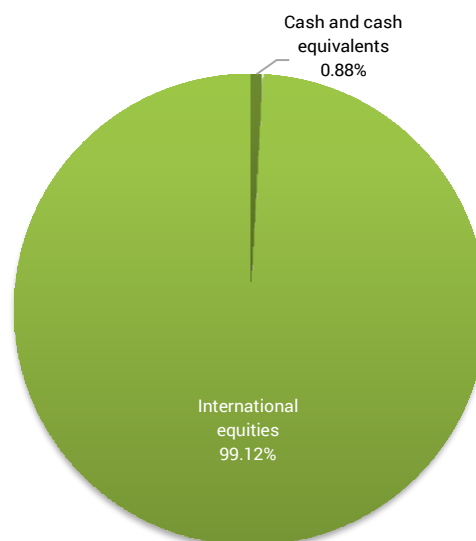
Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$590 (that is -5.90% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total loss after tax of -\$650 for the year.
