

SuperLife UK pension transfer scheme

Overseas Non-government Bonds Fund

This is a replacement fund update dated 27 July 2022, which replaces the previous fund update dated 3 May 2022. The table in the "What fees are investors charged?" section has been updated to show the corrected Manager's basic fee, total management and administration charges and total fund charges that were actually charged to investors in the year ending 31 March 2022. They were previously incorrectly published as 0.10% lower than the actual fund charges, as they did not include a 0.10% fee increase that took effect on 1 April 2021.

Fund update for the quarter ended 31 March 2022

This fund update was first made publicly available on 27 July 2022.

What is the purpose of this update?

This document tells you how the Overseas Non-government Bonds Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Invests in international bonds and is designed to reflect the return (before tax, fees and other expenses) on international non-government bond markets of developed economies.

What are the risks of investing?

Risk indicator for the Overseas Non-government Bonds Fund


How has the fund performed?


Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$361 (that is -3.61% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total loss after tax of -\$421 for the year.

Currency hedging

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 100% (although the actual hedging level may differ from this because of cash flow and market movements). As at 31 March 2022, 99.61% of the fund's foreign currency exposure was hedged.
