SuperLife Balanced Fund

This is a replacement fund update dated 27 July 2022, which replaces the previous fund update dated 3 May 2022. The table in the "What fees are investors charged?" section has been updated to show the corrected Manager's basic fee, total management and administration charges and total fund charges that were actually charged to investors in the year ending 31 March 2022. They were previously incorrectly published as 0.10% lower than the actual fund charges, as they did not include a 0.10% fee increase that took effect on 1 April 2021.

Fund update for the quarter ended 31 March 2022

This fund update was first made publicly available on 27 July 2022.

What is the purpose of this update?

This document tells you how the SuperLife Balanced Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Invests in a mix of income and growth assets and is designed for investors that want a balanced investment option. Negative annual returns may occur once in every 5-7 years on average.


What are the risks of investing?

Risk indicator for the SuperLife Balanced Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

How has the fund performed?

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$237 (that is 2.37% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$177 for the year.

Currency hedging

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 75.50%. The actual hedging level can be anywhere in the 0% - 120% range. As at 31 March 2022, 75.83% of the fund's foreign currency exposure was hedged.
