#### Fund update for the quarter ended 30 September 2022

This fund update was first made publicly available on 31 October 2022.

#### What is the purpose of this update?

This document tells you how the NZ Cash Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### **Description of this fund**

Invests in New Zealand cash (including term deposits) and is designed to provide a return (before tax, fees and other expenses) that outperforms the S&P/NZX Bank Bill 90-Day Index over rolling one-year periods.



#### Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$96 (that is 0.96% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$36 for the year.

- 1 The fund charges will be increasing by 0.10% per annum of the fund's net asset value, from 12 December 2022
- 2 We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. This may be shown as 0.00% due to rounding.
