#### What is the purpose of this update?

This document tells you how the Australian Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### **Description of this fund**

Invests in Australian shares and is designed to reflect the return (before tax, fees and other expenses) of the Australian share market.

#### What are the risks of investing?

#### **Risk indicator for the Australian Shares Fund**




#### Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$1,278 (that is 12.78% of Jess's initial \$10,000). Jess also paid \$60 in other charges. This gives Jess a total return after tax of \$1,139 for the year.

#### **Currency hedging**

As at 31 December 2024 the fund's exposure to assets denominated in foreign currencies was 99.78%, of which 51.70% was hedged. This means the fund's unhedged foreign currency exposure was 48.19% of the net asset value of the fund. #### **Notes**

1 These charges refer to the normal fund operating costs that are charged to the fund. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. Some of these are fixed costs so the amount shown can range from 0% up to the total fund charges depending on the total value of the fund.
