What is the purpose of this update?

This document tells you how the Emerging Markets Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

What are the risks of investing?

Risk indicator for the Emerging Markets Fund

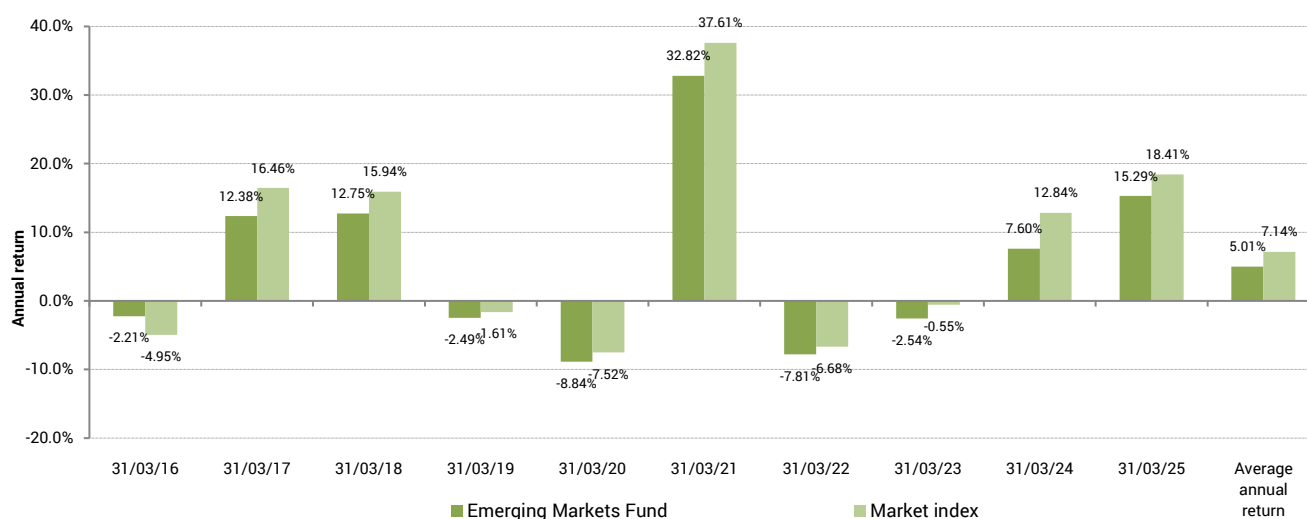
How has the fund performed?

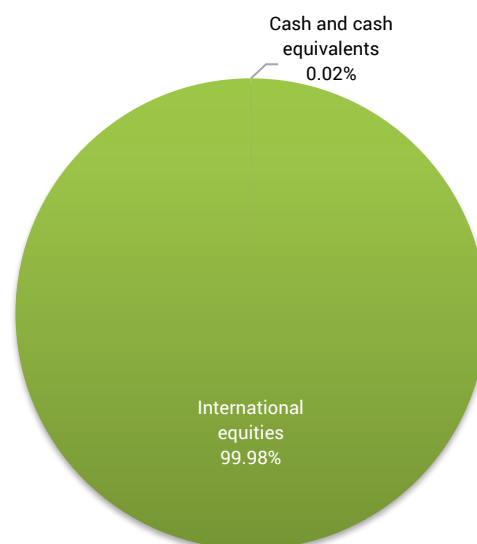
Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$1,626 (that is 16.26% of Jess's initial \$10,000). Jess also paid \$60 in other charges. This gives Jess a total return after tax of \$1,469 for the year.

Notes

- These charges refer to the normal fund operating costs that are charged to the fund. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. Some of these are fixed costs so the amount shown can range from 0% up to the total fund charges depending on the total value of the fund.
