### SuperLife workplace savings scheme

### Overseas Non-government Bonds Fund

For the quarter ended 31 December 2016

This fund update was first made publicly available on 13 February 2017.

### What is the purpose of this update?

This document tells you how the Overseas Non-government Bonds Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

The Overseas Non-government Bonds Fund is designed to provide a return (after tax, fees and other expenses) that reflects the after-tax return on international non-government bond markets of developed economies.

### What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

While risk indicators are usually relatively stable, they do shift from time to time. The risk indicator will continue to be updated in future fund updates.

### Other specific risks

There are other risks that may increase the risk to returns for investors, which are not reflected in the risk indicator. These risks include active management risk. In particular, while SuperLife workplace saving's philosophy is that a passive approach to investing will deliver better long-term results, we make some active management decisions. There is a risk that this may result in the fund achieving a return that is lower than the investment objective for the fund.



### How has the fund performed?

The supplement for your employer may allow you to withdraw money from your member account and transfer it to a KiwiSaver scheme. Where the transfer is to a KiwiSaver scheme other than the SuperLife KiwiSaver scheme, you may be charged a withdrawal fee. The fee is \$50.

\*From 9 November 2016, the total fund charges changed to an estimate 0.44% per annum of the fund's net asset value and the administration fee reduced to \$12 per annum. A paper statement fee of \$18 per annum was introduced.

Small differences in fees and charges can have a big impact on your investment over the long term.


### Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$417 (that is 4.17% of her initial \$10,000). Jess paid other charges of \$31<sup>1</sup> (Jess received statements and other SuperLife communications electronically and was not charged the paper statements fee). This gives Jess a total return after tax of \$386 for the year.
