

## Fund Update

### SuperLife workplace savings scheme

#### Asia Pacific ETF Fund

For the quarter ended 30 September 2016

This fund update was first made publicly available on 3 November 2016.

#### What is the purpose of this update?

This document tells you how the Asia Pacific ETF Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### Description of this fund

The Asia Pacific ETF Fund invests in the Smartshares Exchange Traded Funds' Asia Pacific Fund.

#### What are the risks of investing?

##### Risk indicator for the Asia Pacific ETF Fund<sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

This risk indicator is not a guarantee of a fund's future performance. The risk indicator is based on the returns data for 5 years to 30 September 2016. While risk indicators are usually relatively stable, they do shift from time to time. The risk indicator will continue to be updated in future fund updates.

### Other specific risks

There are other risks that may increase the risk to returns for investors, which are not reflected in the risk indicator. These risks include underlying fund tracking risk. In particular, the fund invests in an exchange traded fund, which is designed to track the return on a specific index. Tracking difference may occur when the weighting of each of the financial products included in the index changes, and the fund that tracks the index is not able to exactly match that change. There is a risk that this may result in the fund achieving a return that is lower than the index being tracked by the fund.

Small differences in fees and charges can have a big impact on your investment over the long term.

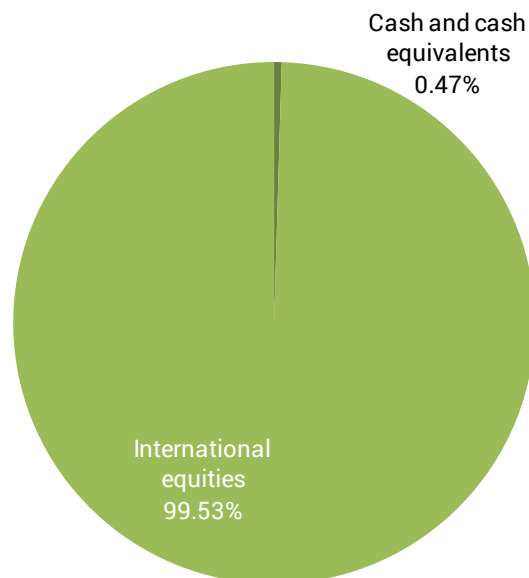
### Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$30 (that is 0.30% of her initial \$10,000). Jess paid other charges of \$12 (Jess received statements and other SuperLife communications electronically and was not charged the paper statements fee). This gives Jess a total return after tax of \$18 for the year.

### Notes

- 1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 3 years and 11 months of market index returns.
- 2 To the extent that fund charges involve amounts that are fixed as percentages of the net asset value, those amounts have been used to calculate the fund charges. To the extent that amounts are not fixed, a best estimate of amounts has been used.
- 3 Estimates have been used to calculate this amount. In particular, we have made estimates for the costs charged by the supervisor and custodians, the costs charged by the other funds we invest in, and our regulatory and compliance costs. These estimates are based on our experience in respect of other SuperLife managed investment schemes we manage and assume that the fund's actual investment mix will be consistent with the target investment mix set out in the Statement of Investment Policy and Objectives for SuperLife workplace savings scheme.
- 4 You will only be charged this fee if you choose to receive statements and other SuperLife communications in paper form.
- 5 The "Top 10" individual assets listed in the table exclude net current assets and as a result do not sum to 100%. However, to produce an accurate representation of the fund's assets in the "Actual investment mix" graph, net current assets have been included in the cash and cash equivalents asset class.
