What is the purpose of this update?

This document tells you how SuperLife Conservative has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

Invests mostly in income assets. Designed for investors that want a conservative investment option. Negative annual returns may occur once in every 7-10 years on average.

What are the risks of investing?

Risk indicator for SuperLife Conservative




Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$600 (that is 6.00% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total return after tax of \$588 for the year.
