What is the purpose of this update?

Description of this fund

Invests mostly in income assets. Designed for investors that want a conservative investment option. Negative annual returns may occur once in every 7-10 years on average.

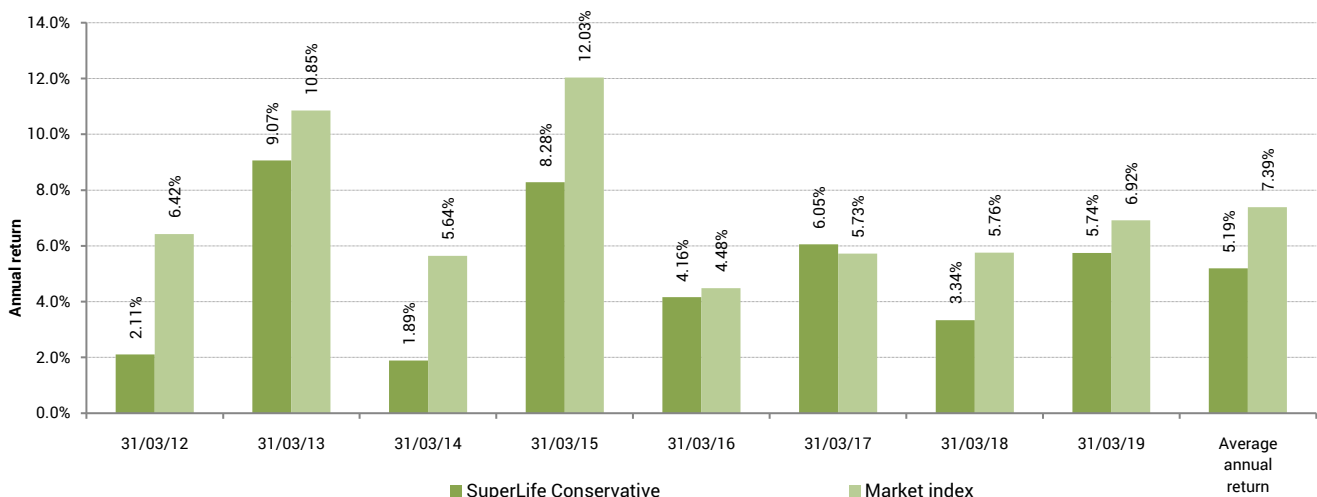
What are the risks of investing?

Risk indicator for SuperLife Conservative



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

How has the fund performed?

Small differences in fees and charges can have a big impact on your investment over the long term.

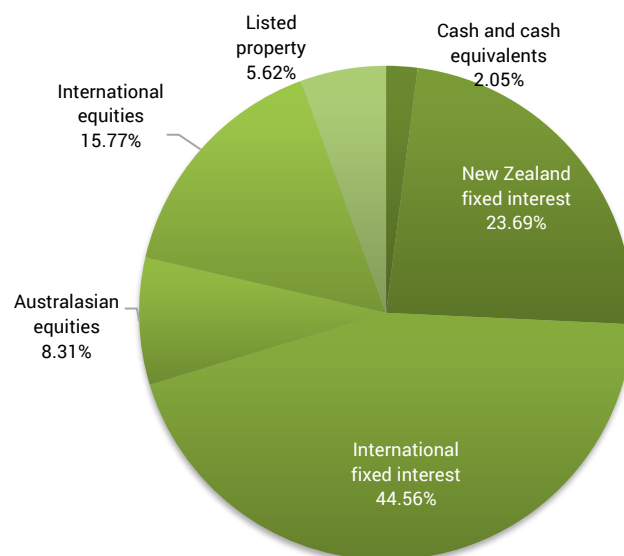
Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$574 (that is 5.74% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total return after tax of \$562 for the year.

The fund's foreign currency exposure may be hedged to the New Zealand dollar, and hedging levels will vary between 0% and 110%. As at 31 March 2019, 97.37% of the fund's foreign currency exposure was hedged.
