### Fund update for the quarter ended 31 March 2020

This fund update was first made publicly available on 1 May 2020.

### What is the purpose of this update?

This document tells you how the Emerging Markets Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

The Emerging Markets Fund is designed to provide a return (after tax, fees and other expenses) that reflects the after-tax return on international share markets of emerging economies.

### What are the risks of investing?

#### Risk indicator for the Emerging Markets Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


### How has the fund performed?

## Annual return graph



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 March 2020.

## What fees are investors charged?

Investors in the Emerging Markets Fund are charged fund charges. In the year to 31 March 2020 these were:

GST is included in the fund charges set out above.


## Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$877 (that is -8.77% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total loss after tax of -\$889 for the year.
