What is the purpose of this update?

This document tells you how the S&P/ASX 200 Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

The S&P/ASX 200 Fund invests in Australian shares and designed to track the return (before tax, fees and other expenses) on the S&P/ASX 200 Index.

What are the risks of investing?

Risk indicator for the S&P/ASX 200 Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


Example of how this applies to an investor

Jess had \$10,000 in the fund on 15 July 2020 and did not make any further contributions. On 31 March 2021, Jess received a return after fund charges were deducted of \$1758 (that is 17.58% of her initial \$10,000). Jess paid other charges of \$8. This gives Jess a total gain after tax of \$1750 for the 8 months and 15 days.

Notes

- 1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 4 years and 4 months of market index returns.
- 2 We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges.
- 3 The administration fee in the year to 31 March 2021 is stated net of an income tax deduction that was applied in calculating your PIE tax payable (the deduction was paid to us). On 1 April 2021, we stopped doing this – this means that if your prescribed investor rate is 10.5%, 17.5% or 28%, the total fee you will now pay us will be lower.
- 4 The top 10 investments listed in the table exclude current assets and current liabilities, and as a result do not sum to 100%.
