SuperLife Age Steps - Age 40 ¹

This is a replacement fund update dated 29 May 2024, which replaces the previous fund update dated 10 February 2023. The market index return data in the "How has the fund performed?" section, including the annual return graph, has been updated to show correct market index returns over the relevant periods.

Investment update for the quarter ended 31 December 2022

This investment update was first made publicly available on 29 May 2024.

What is the purpose of this update?

This document tells you how SuperLife Age Steps - Age 40 (the stage) has performed and what fees were charged. The document will help you to compare the stage with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this stage

SuperLife Age Steps automatically sets the proportion of your investment in income and growth assets based on your age. As you get older, the proportion of your investment in more volatile growth assets will be reduced, lowering the expected size of the ups and downs in the value of your investment. This option may be suitable if you are saving for retirement (assumed to be age 65), and assumes you will continue to invest your savings and spend them over your retirement period.

Your SuperLife Age Steps - Age 40 investment will be allocated 20.8% to income assets and 79.2% to growth assets.

What are the risks of investing?

Risk indicator for SuperLife Age Steps - Age 40



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the stage's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

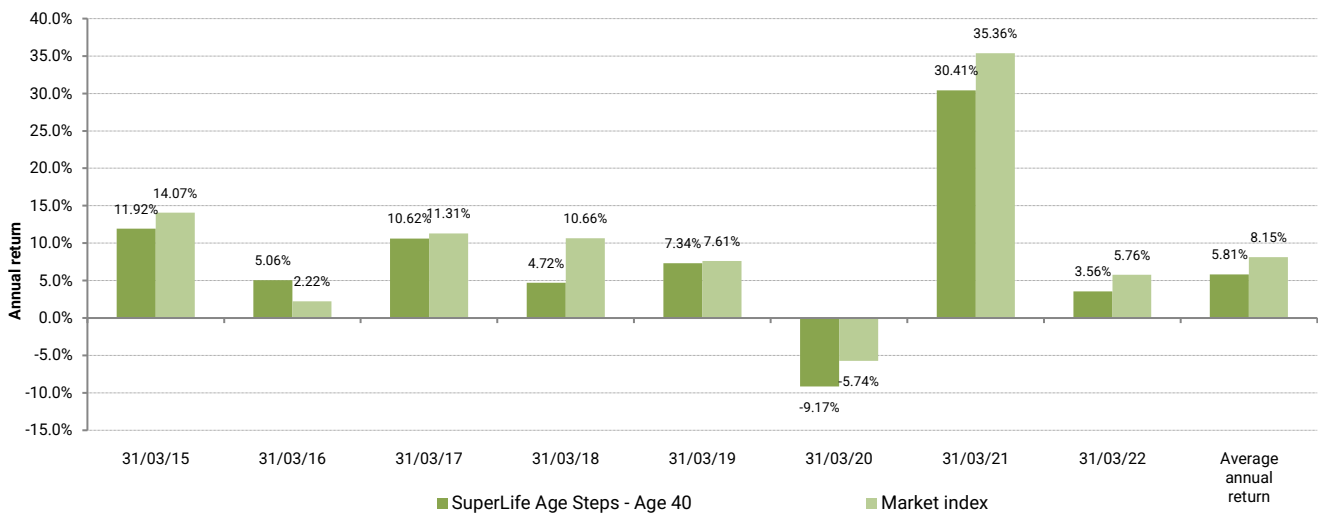

Annual return graph



This shows the return after fund charges and tax for each year ending 31 March since the stage started. The last bar shows the average annual return since the stage started, up to 31 December 2022.

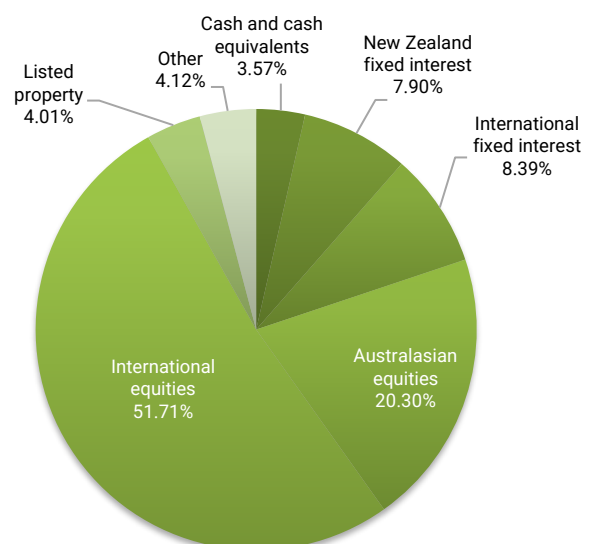
Example of how this applies to an investor

Jess had \$10,000 in the stage at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted but before tax of \$-1131 (that is -11.31% of Jess's initial \$10,000). Jess also paid \$12 in other charges. This gives Jess a total loss after tax of \$-1187 for the year.

Notes

- 1 SuperLife Age Steps - Age 40 does not currently have any investors. The information in this document sets out our estimates as to how SuperLife Age Steps - Age 40 would have performed and what fees would have been charged if it had investors. These estimates are based on our experience in respect of SuperLife Age Steps - Age 40 in the other SuperLife managed investment schemes.
- 2 The fund charges were increased on 12 December 2022 by 0.10% per annum of the fund's net asset value.
- 3 The fund charges for SuperLife Age Steps are estimates based on the target investment mix of underlying funds for each age step. The fund charges actually charged may differ from the estimate if the actual investment mix of underlying funds for your investment differs from the target because of market movements.
- 4 We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. This may be shown as 0.00% due to rounding.
- 5 The 'other' category refers to an investment in infrastructure. The underlying investments are infrastructure securities listed in developed countries.
