

# SuperLife workplace savings scheme

## Overseas Shares Fund

This is a replacement fund update dated 24 April 2023, which replaces the previous fund update dated 27 July 2022. The market index return data in the "How has the fund performed?" section, including the annual return graph, has been updated to show correct market index returns over the relevant periods. In previous fund updates, the market index annual return data was calculated incorrectly.

### Fund update for the quarter ended 30 June 2022

This fund update was first made publicly available on 24 April 2023.

### What is the purpose of this update?

This document tells you how the Overseas Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets

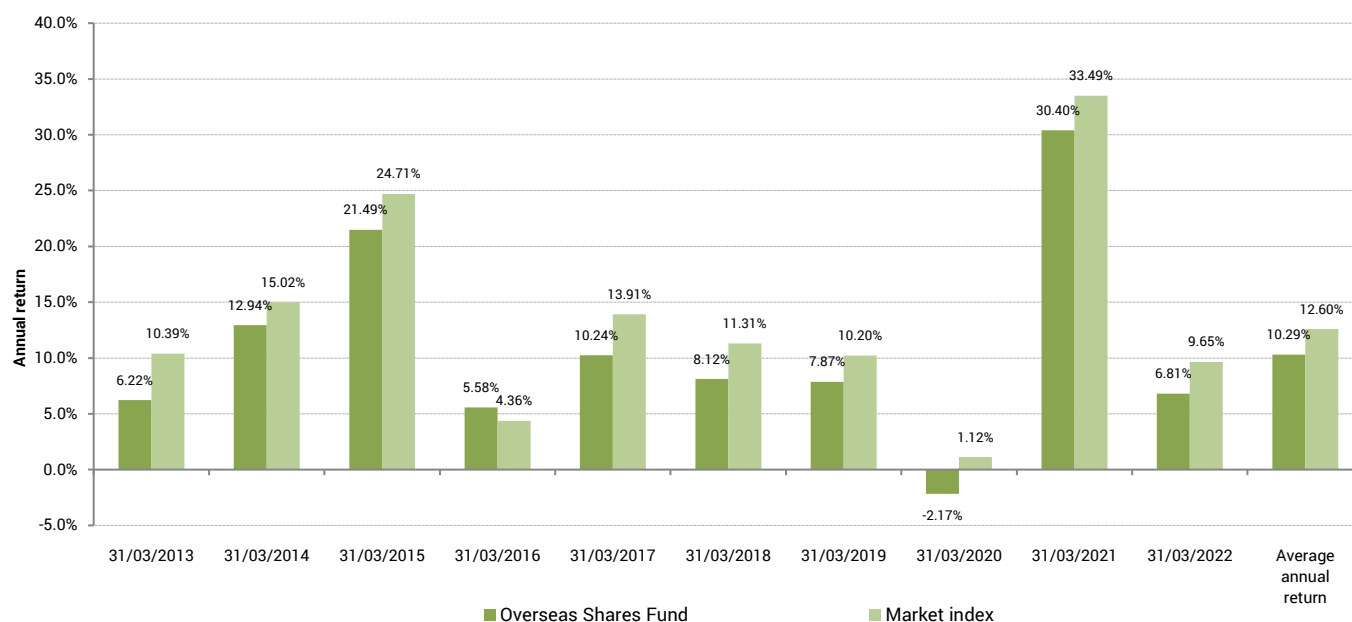

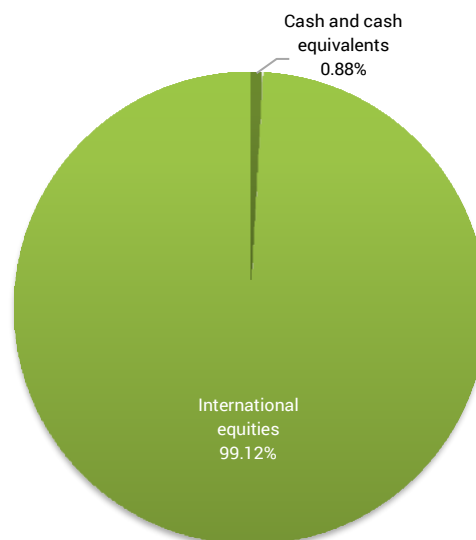
## Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$573 (that is -5.73% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total loss after tax of -\$585 for the year.

### Currency hedging

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 100% (although the actual hedging level may differ from this because of cash flow and market movements). As at 31 March 2022, 95.74% of the fund's foreign currency exposure was hedged.
