What is the purpose of this update?




Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$681 (that is 6.81% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total return after tax of \$669 for the year.

Currency hedging

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 100% (although the actual hedging level may differ from this because of cash flow and market movements). As at 31 March 2022, 95.74% of the fund's foreign currency exposure was hedged.
