What is the purpose of this update?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets



Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$927 (that is 9.27% of Jess's initial \$10,000). Jess paid other charges of \$12. This gives Jess a total return after tax of \$654 for the year.
