What is the purpose of this update?

This document tells you how the Global Property Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets




Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$422 (that is -4.22% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total loss after tax of -\$434 for the year.

The top 10 investments make up 75.71% of the fund's net asset value.

Currency hedging

As at 30 June 2023 the fund's exposure to assets denominated in foreign currencies was 75.21%, of which 98.45% was hedged. This means the fund's unhedged foreign currency exposure was 1.17% of the net asset value of the fund.
