What is the purpose of this update?




Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$150 (that is -1.50% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total loss after tax of -\$162 for the year.

Notes

Some of these are fixed costs so the amount shown can range from 0% up to the total fund charges depending on the total value of the fund.
