What is the purpose of this update?

We exclude assets that do not meet our socially responsible investment standards, and increase or decrease exposure to companies based on their environmental, social and governance (ESG) factors.

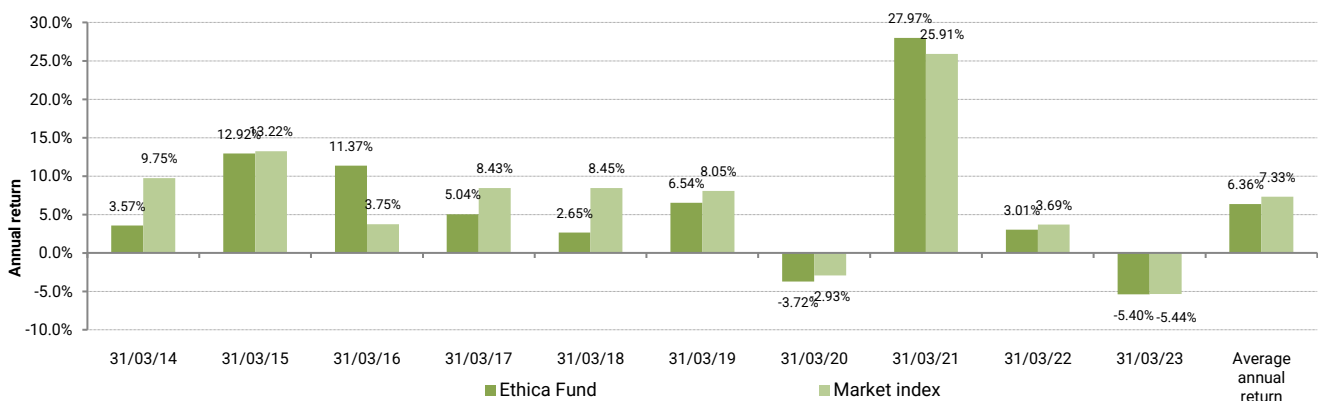
What are the risks of investing?

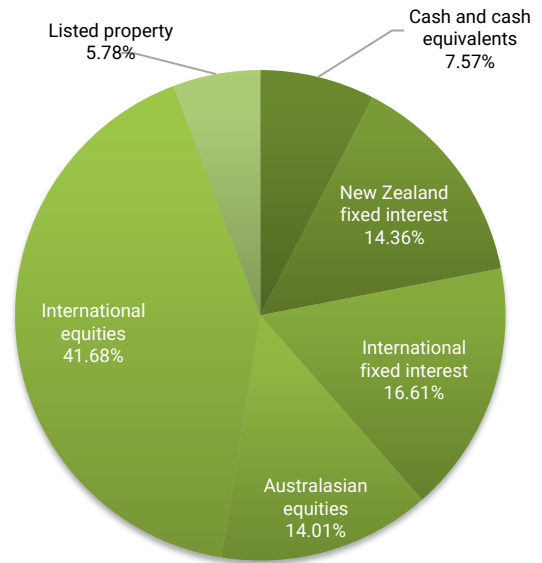
Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$686 (that is 6.86% of Jess's initial \$10,000). Jess paid other charges of \$12. This gives Jess a total return after tax of \$590 for the year.

Currency hedging

As at 30 June 2023 the fund's exposure to assets denominated in foreign currencies was 57.98%, of which 78.01% was hedged. This means the fund's unhedged foreign currency exposure was 12.75% of the net asset value of the fund.
